This course examines the major components of the Criminal Justice System - law enforcement, courts and corrections - including historical and social perspectives; the roles and functions of the various agencies; theories on crime and behavior and the processes involved in the administration of justice.

#### **Course Objectives**


Upon the successful completion of this course the student will be able to:

- 1. Describe the agencies of justice, the formal justice process, and the concept of the informal justice system which involves discretion, deal making and plea bargaining.
- 2. Develop awareness for how justice policy is shaped.
- 3. Describe the nature and extent of crime and victimization.
- 4. Demonstrate an understanding of the relationship of criminal law to the justice system and the historical development and role of law enforcement in the United States.
- 5. Define the role and inter-relationships of the police, courts, and correctional system components of the criminal justice system.
- 6. Demonstrate understanding of the state and federal court systems.
- 7. Define the basic terminology of civil and criminal law.
- 8. Identify and demonstrate knowledge of basic constitutional rights.
- 9. Demonstrate an understanding of the punishment philosophy in the United States.
- 10. Demonstrate an understanding of the community supervision of offenders.
- 11. Identify career opportunities in the criminal justice field.

## **Brief Writing Assignments**

A Brief Writing Assignment is a one/two page paper encouraging you to think about the subject matter of this course by applying them to your own life experiences and observations. By reflecting and making connections to the material presented in our course it will enhance learning in a meaningful way. It will also enable me and as well as your classmates to learn more about you, your interests, and thought process as I will ask you to share these with a classmate as well as opening up the opportunity to share them with the whole class. It is not a research paper but an answer to a simple question, in which you demonstrate your understanding of the material by applying it appropriately to your own life and life experiences.

**BWA # 1:** How would you change the criminal justice process as explain in chapter 1 and our class discussion?

**BWA # 2:** What are the ethics of using social media for law enforcement purposes? Is it a valuable asset? A cause for alarm? Is it an undesirable invasion of individual privacy, or does it represent a positive advance in security measures that generates benefits for society? See page 108 of our textbook for further resources.

**BWA # 3:** Should prosecutorial discretion be enhanced, curtailed, or eliminated?

**BWA # 4:** Write about your experience in the group project. What you learned about yourself, the material, and the people you worked with.

## **Presentation**

Chapter 14 is titled, Crime and Justice in the New Millennium. Groups of students will be researching and expanding upon the topics covered in this chapter. The groups will develop a lesson plan, handouts, activities and more with a goal of presenting their work to other students.

Each individual student will write a paper regarding their work: BWA # 4.

#### **Current Event Article**

Students will locate and send electronically (via the SMCC email system) to all students and the instructor in our class. A current article should be on a topic in the criminal justice system. We will have a brief discussion of the article led by the presenting student. The article will be sent at least 4 days prior to class presentation to give time for others to read. Articles cannot be repeated and presentation dates will be assigned.

## **End of Course Evaluation**

Students complete evaluations for each course attended at SMCC. Evaluations are submitted online and can be accessed through the student portal site. Students can access the course evaluation report beginning one week before the end of classes. The deadline for submission of evaluations occurs 24 hours after the last day of classes each semester. Instructors will announce when the online course evaluation is available.

### **SMCC Pay-for Print Policy**

In an effort to control the escalating cost of supplies and to encourage students to conserve resources, SMCC charges for printing. Students receive a \$20 credit every semester. This credit resets for each semester and extra credit is not rolled over to the next semester. Page per costs are as follows:

- 8.5" x 11" black & white: \$0.10 per page
- 8.5" x 11" color: \$0.50 per page
- 8.5" x 14" and 11" x 17" black & white: \$0.20 per page
- 8.5" x 14" and 11" x 17" color: \$1.00 per page

#### Add-Drop Policy

Students who drop a course during the one-week "add/drop" period in the fall and spring semesters and the first three days of summer sessions receive a 100% refund of the tuition and associated fees for that course. Please note any course that meets for less than the traditional semester length, i.e., 15 weeks, has a pro-rated add/drop period. There is no refund for non-attendance.

#### Withdrawal Policy

A student may withdraw from a course only during the semester in which s/he is registered for that course. Early withdrawal for full semester-length courses is from day 7 - 10 of the semester. Official withdrawal from a course during this period results in a 50% refund of course tuition and fees. Official withdrawal after the early withdrawal period is available through week twelve of semester-length courses and week nine of summer courses. This period is pro-rated for shorter length courses (75% of the course length). There is no refund of tuition or fees

associated with a withdrawal following the early withdrawal period. The designation "W" will appear on the transcript after a student has officially withdrawn. A course withdrawal is an uncompleted course and may adversely affect financial aid eligibility. Failure to attend or ceasing to attend class does not constitute withdrawal from the course.

## Plagiarism Statement

Adherence to ethical academic standards is obligatory. Cheating is a serious offense, whether it consists of taking credit for work done by another person or doing work for which another person will receive credit. Taking and using the ideas or writings of another person without clearly and fully crediting the source is plagiarism and violates the academic code as well as the Student Code of Conduct.
