**Statement of Purpose**

Southern Maine Community College (SMCC) and Southern New Hampshire University (SNHU) have entered into this transfer articulation agreement. The purpose of this agreement is to facilitate student academic transfer and provide a smooth transition from a two-year community college to a university. It is recognized that this agreement shall describe the required program of study at SMCC for admission eligibility to SNHU and the Baccalaureate Degree Program indicated.

**Terms and Conditions of Academic Credit Transfer**

**To: Bachelor of Science in Technical Management**

(Name of SNHU Academic Program/Degree)

**From: Associate in Applied Science in Fire Science Technology**

(Name of SMCC Academic Program/Degree)

The evaluation and transfer of earned college credits shall be in compliance with state and federal education policies and institutional and academic program accreditation standards pertaining to undergraduate academic transfer. Current students and graduates who have earned degrees from Southern Maine Community College shall be eligible for credit evaluation under the terms of this agreement.

Transfer students will be accorded the same standards and criteria for admission to a major degree sequence as SNHU students. All applicants accepted to SNHU's Baccalaureate programs must fulfill the graduation requirements of the granting institution as identified in Appendix A & B.

**Articulation Implementation and Agreement Review**

The Chief Academic Officer designee of *the collaborating institutions* shall be responsible for implementing this agreement, for identifying and incorporating any changes into subsequent agreements, and for conducting a *periodic review of this agreement*.

This agreement includes specific requirements for admission into a program, outlines requirements, and indicates which degree or diploma can be used to meet program prerequisites as well as general education, major or program, and graduation requirements.

**Admissions requirements:**

For College of Continuing Education applicants: Students must submit an application form, an official final high school transcript and official transcripts for all colleges and universities previously attended.

**Requirements for the Bachelor of Science in Technical Management**

Students must take 30 credits from SNHU for academic residency and at least 12 credits from SNHU in the major. Students must also take two courses from SNHU identified as "Global Marker" courses. These courses may also fulfill other SNHU degree requirements.
